#### SIDE LETTER OF AGREEMENT

#### BETWEEN

## THE NEW BEDFORD SCHOOL COMMITTEE ("Committee")

#### AND

# THE NEW BEDFORD EDUCATORS ASSOCIATION, INC., UNIT A ("Union")

Collectively referred to as ("the Parties")

### April 2023

WHEREAS, the Parties engaged in bargaining over the impacts of student assessments in preschool as such relate to employees represented by the Union; and

WHEREAS, the Parties wish to memorialize their understanding of their negotiations.

**NOW THEREFORE**, the Parties hereby agree as follows:

- 1. The Parties agree to implement preschool assessments as follows:
  - a. The District shall provide, and teachers shall attend, professional development sessions concerning preschool student assessments on the following dates: February 8, 2023; March 22, 2023; and May 24, 2023. Such professional development shall take place within the work day. The District will also provide teachers with a sample student assessment as part of the professional development process.
  - b. Teachers shall participate in an initial preview of the student assessment process for the third trimester of the 2022-2023 school year, but are under no obligation to perform student assessments during that time. During the first trimester of the 2023-2024 school year, teachers shall be required to complete the student assessments and will have the option to provide such to the families. Beginning the second trimester of the 2023-2024 school year, teachers shall be required to complete and issue student assessments to families.
  - c. During the third trimester of the 2022-2023 school year and first trimester of the 2023-2024 school year, teachers shall only be required to utilize the standards of social and emotional learning and literacy. Beginning the second trimester of the 2023-2024 school year, teachers will additionally be required to assess students on the standard of language. The District reserves the right to modify and/or increase the standards for student assessments and shall give the Union notice and opportunity to confer about such.
  - d. The District, in its discretion, shall provide teachers with electronic devices necessary to complete the assessments.
  - e. The District shall evaluate the assessment process by issuing surveys and/or other

appropriate method of obtaining feedback to teachers in both June 2023 and the fall of 2023.

- f. The District will issue a memorandum to parents/guardians of students enrolled in preschool ahead of the 2023-2024 school year addressing the assessments which shall go into effect that school year. In addition, teachers shall discuss the assessments during the 2023-2024 school year Open House with parents/guardians.
- 2. The Committee has satisfied any and all bargaining obligations pursuant to MGL c. 150E with the Union with respect to the use of assessments in preschool.
